

## CAR RENTAL TERMS & CONDITIONS

**Condition of Rented Automobile (VEHICLE).** Customer is aware and acknowledges that the VEHICLE has been delivered to Customer in good condition & agrees to return VEHICLE in the same condition.

**Authorization to charge Credit Card on file.** Customer authorizes TCL to charge customer's credit card for all charges owed to TCL by Customer under this agreement, including but not limited to rental fees, fuel charge, traffic citation, towing, lost of use and/or damage keys, detailing fees and any uninsured damage to the VEHICLE.

**Security Deposit:** Is required, amount will be determine at the time of rental. Security deposit maybe used or withheld to pay for any outstanding balance and/or damages to rental vehicle.

**Collision Damage Waiver (CDW).** I understand that by accepting CDW; I am fully responsible for the stated deductible amount owed to TCL unless the damage is estimated LESS than the stated deductible amount. If I decline CDW, I understand that I am fully responsible for all damage repair amount up to the retail value of vehicle and any additional fees that are related to the repairs.

**CDW does not cover** any loss to VEHICLE by (1) any driver(s) who have not been authorized by TCL, (2) while the VEHICLE is being operated in violation of the terms of agreement, (3) while any person(s) operating VEHICLE is/are under the influence of alcohol or any drugs or controlled substance, or (4) that is not evidence by a valid police report. Customer acknowledges that CDW does NOT apply to the interior and exterior stains in/on AUTO, or theft, damage to VEHICLE's tires, rims, and/or windows. Initial: \_\_\_\_\_

**Super Damage Coverage (SDC).** SDC terms & conditions are the same as CDW but with a lower Deductible of \$100.

**Failure to return VEHICLE as scheduled.** If Customer fails to return vehicle when scheduled or contact TCL to make the extension arrangements, TCL will contact the Guam Police to report VEHICLE as an Unauthorized Use of a Motor Vehicle. Customer shall pay for each additional day or days and any incidental charges until VEHICLE is returned to TCL Car Rental.

**No Off Road Driving.** The VEHICLE must be driven at all times on paved, government roads, Customer is liable to TCL for all damage to VEHICLE caused in whole or part by a violation of this clause of this agreement.

**Use of Vehicle.** Customer agrees that the VEHICLE shall not be used for any illegal purpose, racing, towing, commercial freight purpose, off road recreation, or transport of any flammable/hazardous material/waste. Customer will reimburse TCL for all damages, attorney fees and cost TCL may suffer from any violations of this section of this Agreement.

**Accidents.** Customer must report all accidents to TCL and the police at the time of accident. Customer shall assist TCL in the investigation, defense of prosecution and submission of all claims. Customer shall not enter into any settlement agreement with any Third Party after an accident. TCL is the only authorized party.

**Traffic and/or Parking Tickets.** Customer is responsible for payment of all parking and traffic citations or violations arising from the use of this VEHICLE registered to TCL Car Rental.

**Gasoline.** Customer must return VEHICLE with the same level of gas when vehicle was checked out. Also Customer agrees to pay \$10.00(A,B,C) or \$12(D & E) per every 1/8 of a tank.

**Personal Effects & Items.** TCL Car Rental is not responsible or liable for any and all personal effects and items left in VEHICLE after it has returned. Initial: \_\_\_\_\_

**Theft of Personal Items.** TCL Car Rental is not liable for thefts of personal items left in AUTO during rental period. Initial: \_\_\_\_\_

**No Smoking & Foul Odors.** Absolutely NO Smoking in VEHICLE. Customer agrees to pay vehicle reconditioning fee of up to \$250.00 should the VEHICLE be returned with smoke or foul odors in the interior of VEHICLE. Initial: \_\_\_\_\_

**Detailing.** If Customer returns VEHICLE with excessive dirt, sand, or stains to the interior, a fee of up to \$250 will be assessed.

**Damage to Tires / Rims:** Customer is aware that if there are any damage to tire(s) / rims(s) during rental. Customer is responsible to either repair or replace tire(s) / rim(s).

**Authorized Driver's:** All driver's must be listed on this rental agreement. **If unauthorized driver** is found to be driving this vehicle, the rental agreement will be voided and renter shall surrender vehicle immediately to TCL, forfeit all moneys paid including security deposit and pay for any damage to rental vehicle.
